American System of Judging

RULES:

1. The feature booth provides members with an opportunity to acquaint the public with a specific phase of their club or chapter work. The booth can show what they have learned, the activities in which they have participated or the contributions they have made to their community. Judges insist on a high quality of products and materials used in the exhibit.
2. A high scoring exhibit will be artistically arranged, colorful, attractive and well lighted. The club name is to be on display. The exhibit should have a title, preferably one indicating action. The booth should be informative and have educational value. All captions should be visible. Simplicity and essential focal point are important. Trophies, award ribbons or plaques should not be included. No crepe paper or streamers are to be used.
3. Protective ropes, wires or fencing should not distract from the display.
4. Feature Exhibits (booths) shall be limited to one entry by club, chapter or group.
5. Booths must be designed, constructed and installed by club, chapter or group members. Instructors or leaders may not sign entry forms, entry forms need to be signed by the club, chapter or group president. Excessive adult participation will result in a loss of points.
6. Adult members of a Club or Group may enter Division 26.
7. Exhibitors must make arrangements to replace all fruits and vegetables which deteriorate during the Fair. Live plants should be properly cared for. No live animals are to be used. Display must be maintained for the duration of the Fair so it looks presentable. Reasonable efforts should be made to keep electrically operated items in working condition. Failure to maintain a well-kept exhibit may result in the withholding of premium money and awards.
8. No advertising in the booth or acknowledging items borrowed from merchants, etc. Brand names on household items, canned goods, etc. need not be covered if they are part of the display.
9. Booth space no larger than 8'x8'x8'. Exhibitor must supply self standing backdrops.

*****NEW 10. ALL Youth Group Divisions MUST be constructed 100% by the youth exhibitors. Only youth must assemble booth without the help of leaders or chaperones on the fairgrounds.**

STATE FIRE MARSHAL REGULATIONS:

All drapes, hangings, curtains, drops and all other decorative materials, including Christmas trees, that would tend to increase the fire and panic hazard shall be made in a flame-retardant condition by means of a flame retardant solution or process approved by the State Fire Marshal.
