SUBJECT: Livestock Information

DATE: 4/4/11

1. RV reservation forms will go out in the mail on/about 5/10/11 with a return date no later than 7/8/11. If you didn't get one, you are not on my list or you were ineligible. Anyone that had a space in 2010 is on the list; they can call me to be put on the list.
2. Stock Trailers (for feed, etc) parking at east wall – \$50 each space. These are available now. They can come to me directly or through the council to get information and payment. The deadline for this is 7/31/11. Attached are rules. I need the name of the club/organization; the registered owner's name, and the vehicle license # for each space rented. The spaces are limited to a total of 20: 9 for 4-H; 6 for FFA; 3 for Grange; 2 for Independent. Multiple spaces for the same club can only be obtained if the limit has not been reached – but they may purchase a “priority” on the waiting list as I fill these spots based on when it was paid for (first in).
3. Preferred Barn parking spaces go on sale 7/11/11 for approved livestock leaders ONLY, 7/18/11 for livestock exhibitors and 7/25/11 for any other exhibitors. A copy of the policy for Preferred Barn Parking is attached.

Livestock Group Stock/Feed Trailers

1. Limited to 20 Spaces:

4-H	9
FFA	6
Grange	3
Independent	2
2. On sale now at Administration office – see Judy. Cost \$50 each space
3. Multiple spaces for same club can only be obtained if the limit has not been reached. You can obtain priority on the waiting list with payment (refunded if no space available).
4. Include information:
 - Name of Club/Organization
 - Registered owner of trailer
 - License # of trailer
5. Rules:
 - a. Park in your assigned space. Match the number on your pass to the number on the wall/post.
 - b. Attach the 2011 Trailer Pass to the trailer where it can be seen from the street.
 - c. NO other vehicle (cars, trucks, vans, etc.) can be parked AT ANT TIME, FOR ANY AMOUNT OF TIME, FOR ANY REASON, in this space.
 - d. No double trailer's in the space.
 - e. Failure to follow rules will result in removal of trailer from grounds.
 - f. No camping in the trailers. No tents.

Antelope Valley Fair Stock Trailer Parking – Livestock

1. Park stock/horse trailer in your assigned space. Match the number on your pass to the number on the stake.
2. Attach 2011 Trailer Pass to trailer where it can be seen from the street.
3. NO other vehicle (cars, trucks, vans, etc) can be parked AT ANY TIME, FOR ANY AMOUNT OF TIME, FOR ANY REASON, in this space.
4. NO double trailer's in the space.
5. If you cannot abide by the rules, you and your trailer will be asked to vacate the fairgrounds, without refund.
