CODE OF CONDUCT

The Antelope Valley Fair Association is committed to providing a safe, comfortable and enjoyable experience for our guests, both inside our campus and throughout our parking areas.

Please spend a moment to review.

When attending the Antelope Valley Fair, all guests should be aware of and comply with the Code of Conduct.



These activities are prohibited at the Antelope Valley Fairgrounds:

1. Running, shouting, horseplay, throwing of any type of debris.
2. Disorderly or disruptive conduct of any type.
3. Threatening, belligerent or hostile behavior of any type.
4. Standing or walking in large groups that block movement of the A.V. Fair patrons or cause inconvenience to others.
5. Blocking any building, booth, exhibit, concession stand, performance, ticket window, gate, stage, doorway, walkway, fire exit or stairway.
6. Bicycle riding, skateboarding, rollerblading, moped riding, segway riding, unlicensed carts, or skating of any kind on A.V. Fairgrounds.
7. Bringing in alcoholic beverages, narcotics or any illegal substance.
8. Use of loud or obscene language or gesture or other offensive behavior that interferes with A.V. Fair patron's enjoyment of activities and events at the A.V. Fair.
9. Littering.
10. Sitting on or placing feet on table tops.
11. Spitting.
12. Being on A.V. Fairgrounds without shoes, shirt, or wearing vulgar, offensive attire.
13. Bringing pets on A.V. Fairgrounds with the exception of service animals.
14. Soliciting for sale, offering for sale, or selling goods or services by non-concessionaries. (The sales of goods and services may only be conducted in a designed commercial space by approved concessionaries upon payment of a fee for such commercial space. Applications for such commercial space may be obtained from A.V. Fair commercial sales department).
15. Interfering with A.V. Fair business or interfering with the conduct of business by A.V. Fair concessionaires or exhibitors.
16. Soliciting contributions or signatures, leafleting, picketing or displaying signs, posters or banners except in designated areas assigned by A.V. Fair by permit upon proper application, subject to A.V. Fair rules for non-commercial expressive activity.

17. Distributing buttons, bumper stickers, hats, balloons, T-shirts, novelty items, food beverages by non-concessionaires.
18. Any activity that could result in physical harm to person or property.
19. Possession of any article defined as a weapon.
20. Any act defined by federal, state, or local statute or ordinances as constituting a crime.
21. Patrons are allowed to bring single wagons; no attached wagon trains are permissible on A.V. Fairgrounds property, any attached cooler compartment cannot exceed 12" x 18".
22. Selfie sticks are strictly prohibited.
23. All persons entering A.V. Fairgrounds agree that they are subject to a protective screening and/or search for weapons, narcotics, alcohol and illegal items.
24. Please obey all non-smoking signs within the facility.

Violation of these Rules of Conduct will constitute cause for removal of the violator from the A.V. Fairgrounds.

Private Property

Parking for A.V. Fairgrounds events only. All parking regulations strictly enforced. All roads are fire lanes. No overnight parking of unauthorized vehicles and/or vehicles not parking in properly marked stalls will be towed at the vehicle owner's expense.

This property is monitored 24 hours a day by video surveillance. Commercial photography and filming takes place during all normal business hours.
